**Additional Information:**

- All property owners, users and customers of the District agree to abide by the District's Rules and Regulations as these now exist and may be modified from time-to-time.
- All District permanent and interim customers are subject to the monthly First Responder Service Fee effective as soon as a tap/connection is sold.
- Tampering with the District's water system carries a minimum penalty of \$1,000 plus costs.
- There's no free water at any time within the District's boundaries. All water must be paid for.
- The District charges a monthly fee for street lights which is mandatory.
- Mandatory \$100.00 deposit to start service payable with cash, check or money order.
- Trash collection service by the District's chosen contractor is not mandatory.
- A Penalty of \$15.00 will be assessed if payment of full account balance is not received by the 25<sup>th</sup> of the month.
- Total account balance must be paid by the last day of the month or services will be disconnected. A \$60.00 reconnection fee will be applied.

**Water:**

- \$16.00 Per Month-Administrative Service Charge.
- \$ 3.00 Per Month-Capital Improvement Service Charge.
- \$ 3.50 Per 1,000 Gallons-Use Charge up to 7.5kgal/mo. Tier 1
- \$ 4.50 Per 1,000 Gallons-After 7.5 up to 15kgal/mo. Tier 2
- \$ 6.50 Per 1,000 Gallons-After 15 up to 20kgal/mo. Tier 3
- \$10.00 Per 1,000 Gallons-After 20 up to 25kgal/mo. Tier 4
- \$16.00 Per 1,000 Gallons-After 25kgal/mo. Tier 5

**Wastewater:**

- \$ 9.50 Per Month-Administrative Service Charge.
  - \$ 3.00 Per Month-Capital Improvement Service Charge.
  - \$ 6.95 Per Thousand (1000) Gallons-Use Charge.
- (Based on the average monthly water consumption during the months of December & January)
