A comment on petitions, in our Rules and Regulations, we have a policy regarding Citizen Initiatives. Before you go to the Citizen Initiative, please talk to the board, we do listen, and it could save you a lot of extra work!

The Field staff will be installing new water monitor systems in your home in the next few months. Roseanne and Becky our Customer Service Staff will be calling you to set up an appointment time to install these new monitors. It will take the staff 15-20 minutes to install monitors. There is no cost to you for the new monitors. The cost has been collected over time through the Water Capital Improvement Fee on your utility bill. There are several advantages to these new monitors. You can login to the monitoring program and setup your own account to monitor your own water consumption. Ease of data collection for billing purposes, all data is uploaded to the cloud and is downloaded by CCMD once a month for billing. Saving manpower of driving through the district to gather this information in a remote reader, then downloading it into our billing software.

As we move into spring the Field staff will also be budgeting their time between meter installation, other duties and improvements in our parks. For example. We have had complaints about the hard surface in the dog park and sand burrs. We will address those concerns. The Soccer Field/Baseball Field will still be OFF LIMITS until the field staff tells me the grass can hold up to some ruff playing. The grass was started from seed. This is year two for our grass it has lots of bare spots that must be reseeded.

As for other park improvements please send your ideas to the board of directors, we have limited funds we can spend on park improvements. Provided we do not have to spend it on repairing current structures. Remember you and you alone paid for the parks and equipment. Not the County, Not the City, and Not Free Money from a developer or generous friend. Protect your Parks from VANDALISM!
